

Situation: Military Presence

- 4th highest active-duty military presence in US
- 6 major installations (5 DoD, 1 DHS)
- Over 100 National Guard & Reserve facilities
- Over 100,000 active, Guard and Reserve
- 18,000 annual transitions



Who We Are

- The NCMBC is a statewide, **business development and technology transition entity** of the State of North Carolina, embedded in the state's community colleges and headquartered at Fayetteville Technical Community College
- **Totally State-funded**, the NCMBC is the only statewide, military-focused economic development entity in the US, and the only NC entity solely focused on growing the defense economy through existing industry

A LITTLE HISTORY



- ECC was formed in 1985
- Entered the 8(a) program in July 1989
- Graduated in July 1998
- Became an ESOP company in 2005
- Currently working in 20 countries/territories
- Core capabilities:
 - Environmental Remediation
 - Design-Build Construction
 - Munitions Response
 - Renewable Energy Development
 - Emergency/Contingency Response





SCOPE OF WORK (SOW):

- Planning
- Hazard Site Assessments
- Private Property Debris Removal – Residential and Schools
 - Household Hazardous Waste
 - Asbestos Abatement & Disposal
- Debris Removal
 - Temporary Reduction Sites Management
 - Transportation & Disposal
- Dry-in as Tarping roofs, repair windows, replace doors
- Dry-out as in mold removal, dryers, carpet and furniture removal, temporary living
- Facility Repairs
- Reconstruction of destroyed facilities

- Debris removal and Make Safe crews
- Staffing including administrative support, field supervisors, quality control & safety management



ECC has successfully implemented a subcontracting approach to local small businesses during mission responses:

- Initial emphasis to get the mission moving; execution may involve LBs or non-local resources that are teamed with ECC with demonstrated past performance
- Outreach efforts through our website and social media
- Review and compile list from pre-qualification data base
- Transition to local resources expeditiously
- Host local subcontractor outreach efforts
- Connect with local agencies to obtain a list of qualified resources with the appropriate socio-economic status



ECC has successfully implemented a successful approach for subcontracting to local small businesses during mission responses:

- On the current Los Angeles mission – ECC is working closely with the small business office of USACE LA District; they are connecting ECC with their suite of small business prime contractors with proven past performance
 - Currently, ECC has 40 subcontractors working in the field
 - 60% are Greater LA Area based small businesses: 8(a), SDB, WOSB, HubZone, VOSB, SDVOSB
- Similar approach successfully implemented on Maui – ECC predominantly hired subcontractors based/registered in Maui, Hawaii



- Initial efforts include:
 - Establishing call centers
 - Website links for registration
 - Subcontractors submit basic pre-qualification information
 - Share T&Cs ahead of time to identify any major barriers
 - In-person meetings with selected subcontractors to ensure mutual understanding
- Los Angeles Fire Mission Response
 - Efforts focused on local small businesses based in the region
 - Local – from impacted/adjacent communities in Southern California
 - Expand footprint only if there are unfilled resource gaps
 - We do not foresee footprint expansion outside of California

PRE-QUALIFICATION SCREENING

- Capability & resources to perform within timeframe required
- Demonstrated past performance on similar work
- Safety practices and EMR rate
- Established business entities
 - SAM registration (highly recommended)
- Other project-specific requirements:
 - HAZWOPER Training
 - Asbestos certifications
 - State of California licensure
